From the Board of Education Chair,

Dear Canton Community Members,

The Board of Education is deeply grateful to the many parents, caregivers, and community members who have shown up to support our 2025-2026 school budget. Your voices have made a difference, and your commitment to our schools is both seen and appreciated.

Since the pandemic, our schools have made meaningful academic and social-emotional gains thanks to the strategic investments



this community has supported. However, this year's budget reflects a challenging reality: due to an unanticipated spike in health insurance costs, we are presenting a maintenance budget—one that includes no new initiatives and simply covers contractual obligations and fixed costs.

The development of this budget has been a painstaking process, grounded in responsible stewardship of taxpayer dollars. Before reaching the Board of Education, the Superintendent reduced his preliminary budget by nearly \$850,000. After extensive public meetings and careful review, the Board of Finance applied an additional \$158,000 reduction, bringing the total cuts to over \$1 million from when we started last October.

This budget was not created in isolation. There were no fewer than six public meetings dedicated to budget discussion, during which community members were invited to share input and raise questions. At one of those meetings, a parent expressed a sentiment that resonates: "With these continued cuts, are we still thriving—or merely surviving?"

This is a pivotal moment. The endorsed 2025–2026 budget is the minimum required to sustain the quality of education our students deserve. A strong school system benefits everyonedrives economic growth, sustains property values, and most importantly, nurtures the potential of our most valuable resource: our children

Thank you for standing with us and supporting the future of our schools.

Intergovernmental Revenues **SOURCES OF REVENUE**

Education Cost Sharing (ECS) FY26 -The ECS grant is calculated using a formula that determines how much state funding each town receives for public education. The formula is designed to distribute funds based on student needs and town wealth.

District Revenues

The Special Education Excess Cost Grant (SEECG) is a Connecticut state program that helps school districts cover the high costs of educating students with special needs when those costs exceed a certain threshold. The amount received by schools is determined using several factors, one of which is determined by the pool of available funding set aside in the state budget

Reimbursement from other Towns for Tuition and Special Education Costs-Students who attend Canton Public Schools from other towns are charged the current per pupil expenditure rate for Canton. If the student requires special education services, these costs are also passed on to the student.

Reimbursement for services

Pay to Participate fees - Canton collects Pay to Participate fees from students in grades 7 through 12. These fees are used to directly offset expenses related to

Building Use - Occasionally, the District receives requests from an outside organization for use of an area within our school buildings. When this occurs, Canton charges back if there is a need for a custodian to be on the premises during non-scheduled working hours. There is also a room charge, if applicable.

Grant Revenues

Title I – Title I funds are used to support students by providing additional academic support and learning opportunities in order to close educational

Title II - Title II funds are used to prepare, train, and recruit high-quality teachers, principals, and other school leaders

Title III – Title III funds are used to provide supplemental educational programs for English Learners (EL). The goal of Title III is to help EL students achieve English language proficiency and meet the same academic standards as other

Title IV – Title IV funds are awarded to improve students' academic achievement through access to a well-rounded education, improving school conditions for learning, and improving the use of technology.

Adult Education – This is a cooperative grant with the Farmington Board of Education and is specifically used for providing adult educational opportunities as required by law to the residents of the town of Canton.

IDEA – The Individuals with Disabilities Education Act (IDEA) grants provide funding for special education and early intervention services for children with disabilities. The District allocates these funds to support personnel, professional development opportunities to specifically support our students that require

Commissioner's Network - The Commissioner's Network represents a commitment between local stakeholders and the Connecticut State Department of Education (CSDE) to improve student achievement. The Commissioner's Network grant allows for salary support for a certified Math Interventionist and Instructional Coach, staff supporting tutorial work after school, substitute coverage to support teacher professional learning, and support for staff participating in a Turnaround Committee and/or professional learning, specifically in Canton Middle School.

Open Choice - The Open Choice Grant, supported through the district's long standing participation in the Open Choice program, provides financial support for initiatives aimed at enhancing educational opportunities and overall district

Mental Health Supports - In FY26, Canton is scheduled to receive ARPA funding to support the mental health of all students attending Canton Public Schools. These funds will be dedicated to support the salaries of social workers districtwide



Understanding the Canton Public Schools Budget

The budgeting process for Canton Public Schools is a crucial aspect of ensuring effective financial management and the delivery of high-quality education to students. The administration employs a strategic and comprehensive approach to budgeting, beginning with a forecasted budget which is compiled in the fall and presented in December. This first look approach enables Administration to access critical budget drivers as early in the process as possible.

In conjunction with the Town of Canton Board of Finance and Board of Selectmen, The Administrator's Proposed budget used the consumer price index to aid in the forecast as well as the FY26 budget development process. This process involves a thorough review of each line item in the budget, requiring administrators and department heads to provide detailed justifications for all proposed expenses. By examining the necessity of each expense, the school district can identify areas for cost savings and allocate resources based on current needs and priorities.

Forecasting for the Future

The administration and Canton Board of Education places a strong emphasis on forecasting for the future. The school district recognizes the importance of anticipating changes in enrollment, economic conditions, and educational trends to make informed financial decisions. The forecasting process involves analyzing demographic data, enrollment projections, and other relevant factors to predict future resource needs. This forward-looking approach enables the district to plan for potential challenges and opportunities, ensuring that the budget remains flexible and responsive to changing circumstances.



What are the major drivers of the budget increase?

Largest Increases in Board of Selectman Budget:

- Fire Department Incentives

How are local taxes determined each year?

Local taxes are determined by applying the local tax rate, known as the mil rate, to the total assessed value of all property in town. The value of all property in town—including commercial and residential buildings, vehicles, and some personal property—is called the Grand List.

By state law, property is assessed at 70% of its market value. Thus, if a residential property had a value of \$310,418, the assessed value would be \$217,293. The tax on this property would be the assessed value multiplied by the mil rate, divided by 1,000 (a mil). Under this year's proposed mil rate of 33.50, the tax on this property would be \$7,279.11. As a reminder, this is year 2 of the 4-year phase in.

Canton offers property tax abatement programs for eligible taxpayers including veterans and seniors. Information about tax abatement programs and eligibility requirements can be obtained by contacting the Assessor's Office (860-693-7842) and the Senior & Social Services Office (860-693-5811).

What do I need to know about the proposed budget?

This budget will require local property taxes of \$43,991,992. The total proposed budget calls for spending of \$50,816,923, an increase of 4.69% compared to the 2024-25 adopted budget. Note that this increase is caused by increased costs to maintain the Town's current levels of services and not by adding new or expanded services.

What role does the Board of Finance have in the budget process?

The BOF is responsible for managing both the short-term financial needs of the town and its long-term capital planning. In its decision-making process, the BOF tries to balance town services, a strong school system, upkeep of nearly \$120 million invested in the town's infrastructure, the town's AAA bond rating, and the impact of these decisions on the taxes imposed on residents and businesses.
